shareholder is an individual), or absence of the signature of the legal representative and the company seal/stamp (if the shareholder is an organization, where such organization still uses a company seal/stamp); (iii) the envelope has been opened before vote counting; (iv) the ballot is returned to the Company after the prescribed deadline; (v) the ballot is erased, amended or marked with additional symbols;

In case none of the three boxes (Agree, Disagree, No opinion) for the matter subject to voting is marked, but the shareholder still signs, clearly states full name and affixes seal (for organizational shareholders) on the voting ballot, such ballot shall be deemed as "No opinion";

In case a shareholder authorizes another person to exercise voting rights, the authorized person must submit together with the completed voting ballot the original or a duly notarized/certified copy of the Power of Attorney issued by the competent authority ("Power of Attorney"). Any voting ballot not accompanied by the Power of Attorney shall be deemed invalid.
