Pursuant to the Government's Decree No. 05/2019/ND-CP dated 22 January 2019 on internal audit (the "Decree 05");

Pursuant to the Charter of Taseco Air Services Joint Stock Company dated 22 June 2026;

Pursuant to the Internal Audit Regulations of Taseco Air Services Joint Stock Company issued together with Resolution of the Board of Directors No. 04/2022/NQ-HĐQT dated 01/06/2022 (the "Internal Audit Regulations");

Pursuant to the Minutes of the Meeting of the Board of Directors of the Company ("BOD") No. /BB-AST-HĐQT dated August 01, 2026.

RESOLVES:

Article 1. Establishment of the Internal Audit Department

1. To establish the Internal Audit Department of Taseco Air Services Joint Stock Company under the Board of Directors.

2. Organizational structure: The Internal Audit Department of Taseco Air Services Joint Stock Company shall comprise four (04) members, including one (01) Head and three (03) members.

3. The functions, duties, powers, operating principles and working relationship between the Internal Audit Department and the Company's departments/divisions and affiliated units shall be governed by Decree 05, the Internal Audit Regulations, the Company's internal regulations and other applicable laws.

Article 2. Appointment of Members of the Internal Audit Department

1. To appoint members of the Internal Audit Department of Taseco Air Services Joint Stock Company from 01/08/2026, comprising the following members:

2. Members of the Internal Audit Department shall perform their duties as assigned by the Head of the Internal Audit Department in accordance with Decree 05, the Internal Audit Regulations, the Company's internal regulations and other applicable laws.

Article 3. Implementation

1. To authorize the Chairman of the Board of Directors to decide on: The remuneration and other benefits (if any) for each member of the Internal Audit Department.

2. To assign the Head of the Internal Audit Department to take charge of organizing and implementing the activities of the Internal Audit Department in accordance with its assigned functions, duties and powers; to develop the internal audit plan; assign specific duties to each member; organize the implementation of periodic and extraordinary reports; and be accountable to the Board of Directors for the performance of the functions, duties and powers of the Internal Audit Department.

3. To assign the General Director to direct the Company's departments/divisions and affiliated units to cooperate with the Internal Audit Department in the performance of its duties and to ensure the provision of information, records, documents and explanations as lawfully requested by the Internal Audit Department.

Article 4. This Resolution shall take effect from the date of its signing. Members of the Board of Directors, the General Director, members of the Internal Audit Department, the Company's functional departments/divisions, affiliated units and relevant individuals shall be responsible for the implementation of this Resolution. ✓
